The option was originally granted 11-19-02 (1,000,000 shares under the Issuer's 1999 Founders Stock Option Plan and 200,000 under the Issuer's Stock Incentive Plan). Generally, the grant provides for pro rata vesting of 25% per year on each of the first through fourth anniversaries of the grant date, subject to the terms and conditions of the applicable plan and stock option agreement. The exercise price was the closing price on the grant date.
