Explanation of Responses:

- This Form 4 reports the acquisition on August 1, 2018 of 85,192 Performance Based Restricted Stock Units (the "PBRUs") from the attainment of performance goals under an award made to the Reporting Person on March 6, 2017 (the "PBRU Award"). The PBRU Award covered a performance period of six consecutive fiscal quarters beginning with the quarter commencing January 1, 2017 (the "Performance Period"), and the number of shares eligible for vesting was based upon the Issuer achieving certain Adjusted Non-GAAP EBITDA performance goals for the Performance Period. The PBRUs also include an additional equity award based on the Issuer's achievement of certain market share and free cash flow performance goals for the Performance Period.
- Includes an aggregate of 256 shares acquired by the Reporting Person under the Issuer's Employee Stock Purchase Plan for the fiscal quarter ended June 29, 2018.
- This disposition transaction reflects shares withheld by the Issuer in connection with the PBRU Award to satisfy the Reporting Person's tax withholding obligations. The Issuer will pay these taxes on behalf of the Reporting Person.
