Explanation of Responses:

- This sale transaction was made pursuant to the Reporting Person's existing Rule 10b5-1 Plan (i.e. a stock trading plan designed to comply with Rule 10b5-1 of the Securities Exchange Act of 1934, as amended). These shares were initially reported on an earlier Form 4 for the Reporting Person pursuant to a Restricted Stock Unit ("RSU") award made to such person by the Issuer's Board of Directors/Compensation Committee effective June 4, 2007 under the Issuer's 2000 Stock Incentive Plan, with annual pro rata vesting (generally) over a three year period beginning on the first anniversary of the grant date, subject to the plan and relevant award agreement.
- On June 4, 2009, the Reporting Person vested in 25,000 restricted stock units ("RSUs") and as a result acquired 25,000 shares of common stock of the Issuer pursuant to the Reporting Person's June 4, 2007 grant of RSUs. The RSUs acquisition was previously reported on an earlier Form 4 filed by the Reporting Person. This Form 4 reports the disposition of shares withheld by the Issuer pursuant to the RSUs' grant agreement in order to satisfy the Reporting Person's withholding obligations for various taxes due upon the vesting of the RSUs. The Issuer will pay the taxes on behalf of the Reporting Person.
