- This transaction reports the acquisition, effective November 3, 2010 of 15,000 shares of common stock resulting from the attainment of a performance goal under an earlier award of Performance Based Restricted Stock Units ("PBRU Award") as described in further detail below. The Compensation Committee of the Issuer originally awarded 50,000 PBRUs to the Reporting Person with an effective grant date of June 2, 2008 subject to the Issuer's 2000 Stock Incentive Plan and a related award agreement. The PBRU Award vests generally over a three-year (twelve quarter) period but only upon the Issuer achieving certain adjusted non-GAAP earnings before interest, taxes, depreciation and amortization ("EBITDA") base and target performance measurements as set forth in the PBRU Award agreement.
- This disposition transaction represents shares withheld by the Issuer pursuant to the Reporting Person's June 2, 2008 award of Performance Based Restricted Stock Units ("PBRUs"). On November 3, 2010 certain of these units vested. These shares were withheld to satisfy the Reporting Person's withholding obligations for various taxes and similar items. The Issuer will pay these taxes on behalf of the Reporting Person.
